ABOUT THE EXHIBITION

This exhibition is a showcase for original limited edition prints by contemporary artists. We define a limited edition print as an original artwork that is wholly or primarily created using one or more of the following printmaking processes: lithography, woodcut, linocut, relief print, etching, aquatint, engraving, mezzotint, mono-print or screen print.

ABOUT THE JURORS

Joscelyn Gardner has an MFA from the University of Western Ontario and a BFA (Printmaking) & BA (Film) from Queen's University, Kingston, Ontario. In 2011, she was the recipient of the Biennial Grand Prize at the 7th International Contemporary Printmaking Biennial in Trois-Rivieres, Quebec. Her work is exhibited internationally and has been included in international printmaking biennials across Europe and Latin America since 1994, as well as in the 22nd and 23rd Sao Paulo Biennials. Dale Barrett is Director of the John B. Aird Gallery. He has a B.A. (Fine Arts, 1980) from Asbury University, Lexington, KY. Dale has worked in the art gallery sector for over 30 years, holding positions at the Art Gallery of Hamilton, Oakville Galleries, Inter/Access Electronic Media Art Centre, The Craft Gallery, Ontario Crafts Council, and Prime Gallery. He has also worked as a freelance graphic designer since 1987, producing print materials for public galleries, museums and cultural institutions.

AWARDS

The jurors will assign cash awards: First Prize, \$300; Second Prize, \$200; Third Prize, \$100; The Japanese Paper Place Award for Innovation, \$100; and The Curry's Art Supply Store Award, \$100.

HOW TO ENTER

- Artists are invited to submit jpeg formatted digital images of two artworks on a CD (CDs will not be returned). Detail images may be included if necessary. Each jpeg file must be no more than 1.5 MB in size, and **must be labeled as follows**: Artist's Last Name, Artist's First Name, Title, Size (Height x Width), Date of completion. jpg (ie: Smith, John, *Its a Print*, 8.5 x 11, 2013.jpg).
- All prints must be original, created by the entrant and not previously shown at the John B. Aird Gallery.
- There are no size limitations. All accepted works must be framed (exceptions may be made for oversize work) and fitted with hanging devices. Artworks must be clearly labeled on the back with the name of the artist, title, medium, size, date of production and sale price.
- Artworks that do not conform to the entry rules or were misrepresented on the submission CD may not be included.

In the case of a group claim, (made on behalf of two or more artists), the \$1,000 deductible will be averaged among the claimants.

John B.
